What's Happening and What's New for Nursing Practice?

- National Diabetes Month: Empowering Nurses to Elevate Diabetes Care November marks #NationalDiabetesMonth, and this year's theme, "Take Charge of Tomorrow: Preventing Diabetes Health Problems," is aimed at helping build awareness and support people in managing their diabetes care. - ESI Version 5 for Needle Sticks (From the ENA Huddle discussion) The ESI version 5 on Page 18 lists several "high-risk" conditions which are ESI Level 2. Included in this list is "A needle stick in a health care worker (time sensitive to post exposure prophylaxis treatment)".

Per CDC recommendations:

- 1. Immediately seek medical evaluation from a qualified health care professional because, in some cases, post exposure treatment may be recommended and should be started as soon as possible.
- 2. If Occupational Health is open or has a protocol which involves a provider, then the employee possibly could be referred to them.

The decision by the provider to order and give antivirals should occur within 2 hours of the exposure. Sometimes the source patient must be evaluated for HIV. Female patients may need pregnancy screening. Making the patient a Level 2 and expediting their care is

appropriate. Sometimes the patient is not an employee of the hospital, but medical personnel from the community.

It is helpful to have the number below for the providers: Health care professionals caring for exposed health care workers can call the National Clinicians' Post-exposure Prophylaxis Hotline (PEPline) for advice on managing occupational exposures to HIV and hepatitis B and C viruses. PEPline is available 24 hours a day, 7 days a week, at 1-888-448-4911

Local (San Antonio)

- 1. Adopted Budget
 - 1. The Adopted Budget for Fiscal Year (FY) 2024 was presented to City Council. The Budget Document serves as a policy document, a financial plan, an operations guide and a communications device for the City. <u>View FY 2024</u>

State

Voting was held on November 7th with several propositions on the ballot. A couple which may/could impact healthcare are listed. (Exerts from Texas Tribune)

Proposition 5 creates new endowment for 'emerging' research universities

- 1. Helps other "emerging" research universities across the state enhance their research capabilities with the goal of joining the top public institutions across the country.
- 2. Public universities have two main goals: educating students and advancing knowledge through research that betters society.
- 3. The money would help the school increase enrollment and meet workforce needs in North Texas. Texas State officials said they plan to recruit more faculty whose research focuses on artificial intelligence, life sciences, energy and semiconductors.
- Proposition 10 will increase private investments in Texas, provide faster access to lifesaving trials and solutions, strengthen Texas' medical supply chain and decrease reliance on foreign countries, support job growth and generate high-paying jobs, and make Texas more competitive in the medical manufacturing of medical and biomedical devices, drug therapies, PPE, and other critical health care solutions.
 - 1. Make Texas more competitive in medical manufacturing.
 - 2. Most of the newest life-saving saving drugs, vaccines, and med devices are more likely to be made in Texas.
 - 3. Strengthen Texas' supply chain and decrease reliance on foreign countries.
 - 4. Medical and biomedical manufacturing in Texas will decrease supply chain disruptions.
 - 5. Texas is the ideal location for Life-saving trials and solutions.

Federal

Washington Update (November, 2023)

• North Carolina Enacts Workplace Violence Prevention Law

North Carolina Gov. Roy Cooper recently signed into law H.B. 125 which contains several new provisions related to the health care workforce in the state. Included among these are new requirements for hospitals in the state to protect workers from violence. In addition to developing and implementing a workplace violence prevention plan that includes considerations about facility security and staff training, the law requires every hospital with an emergency department to conduct a security risk assessment and develop and implement a security plan that includes having one law enforcement officer present at all times, with some limited exceptions. The new law also amended North Carolina's existing felony assault statute to extend felony protections to all health care workers. Previous law only covered hospital personnel and licensed health care workers providing care to a patient.

Senate Field Hearing Highlights Nurse Staffing Crisis

On Oct. 27, the Senate Health, Education, Labor and Pensions Committee held a <u>field</u> <u>hearing</u> in New Brunswick, New Jersey, highlighting the myriad issues associated with the nurse staffing crisis currently affecting the nation. Chairman Bernie Sanders, I-Vt. discussed the staffing challenges the country faces including the inability of the system to educate the number of qualified students because of a lack of nursing educators, inadequate working conditions many nurses are forced to work under, workplace violence and lack of support during the pandemic. https://www.help.senate.gov/hearings/overworked-and-undervalued-is-the-severe-hospital-staffing-crisis-endangering-the-well-being-of-patients-and-nurses

Among the recommendations discussed by the witnesses was the Workplace Violence Prevention for Health Care and Social Service Workers Act (S. 1176/ H.R. 2663), which

would compel OSHA to issue a national standard related to workplace violence to mitigate the impact and lasting effect of workplace violence has on nurses and other workers.

The Senate HELP Committee <u>recently approved</u> a bipartisan package to address the health care workforce shortage. Unfortunately, this package did not include ENA priorities for the staffing shortage, such as the Workplace Violence Prevention for Health Care and Social Service Workers Act or the Future Advancement of Academic Nursing Act. https://www.help.senate.gov/chair/newsroom/press/news-chairman-sanders-statement-on-help-committee-bipartisan-passage-of-historic-primary-care-and-workforce-legislation

Current ENA Legislative Priorities

Workplace Violence Prevention for Health Care and Social Service Workers Act\

<u>Current Status:</u> Rep. Joe Courtney, D-Conn., introduced H.R. 2663 on April 18. It was referred to the Education & Workforce, Energy & Commerce and Ways & Means committees to await further action. Sen. Tammy Baldwin, D-Wisc., introduced S. 1176 on April 18. It was referred to the Health, Education, Labor and Pensions Committee to await further action.

House Bill: H.R. 5414 Senate Bill: S. 1346

Prevent BLEEDing Act

• <u>Current Status:</u> Sen. Robert Menendez, D- N.J, introduced S. 1653 on May 17 where it was referred to the Health, Education, Labor and Pensions Committee to await further action. House introduction is expected soon.

Senate Bill: S. 1653

MISSION Zero Act

<u>Current Status:</u> Rep. Michael Burgess, R-Tex., and Rep. Kathy Castor, D-Fla., introduced H.R. 2416 on June 13. It was referred to the Energy & Commerce Committee to await further action.
 Senate introduction is expected soon.

Texas Board of Nursing - Continuing Education Requirements for RNs

All Texas RNs are reminded to review the Texas Board of Nursing's mandatory continuing education re-licensure requirements located on the website at https://www.bon.texas.gov/education_continuing_education.asp#D

There are several factors which must be kept in mind when reviewing the information on the website:

- Course content must meet the stipulation requirements of the Texas Board of Nursing
- The time frame or licensure cycle for repeating the requirement differs from course to course
- The RN's practice type and/or 'float unit' may determine if a nurse needs to take a course
- Advance Practice RNs (APRN) have additional course requirements than RNs
- Course requirements are not automatically met with certification
- Additional education requirements may be added at any time. These requirements are announced in the Texas Board of Nursing's Bulletin.

Current RN Requirements:

- Forensics Evidence Collection
- Older Adult and Geriatric Care
- Nursing Jurisprudence and Ethics
- *Human Trafficking Prevention

*Must be an approved Texas HHS course.

Current APRN Requirements:

- Pharmacotherapeutics
- Tick-Borne Diseases
- *Pain management and prescription of opioids
- *Prescription of opioids
- Authorization to receive information from the Texas Prescription Monitoring Program

* All APRNs with prescriptive authority authorized to prescribe opioids
