What's Happening and What's New In Nursing?

- The US is up to 1,168 confirmed measles cases this year

The U.S. logged 122 more cases of measles this week — but only four of them in Texas — while the outbreaks in Pennsylvania and Michigan have officially ended. There are 1,168 confirmed measles cases in the U.S., the Centers for Disease Control and Prevention said Friday. Health officials in Texas, where the nation's biggest outbreak raged during the late winter and spring, said they'll now post case counts only once a week — yet another sign the outbreak is slowing.

There are three other major outbreaks in North America. The longest, in Ontario, Canada, has resulted in 2,009 cases from mid-October through June 3. The province logged its first death Thursday in a baby that got congenital measles but also had other preexisting conditions.

Another outbreak in Alberta, Canada, has sickened 761 as of Thursday. And the Mexican state of Chihuahua had 1,940 measles cases and four deaths as of Friday, according to data from the state health ministry.

Other U.S. states with active outbreaks — which the CDC defines as three or more related cases — include Colorado, Kansas, Montana, North Dakota, Ohio and Tennessee.

In the U.S., two elementary school-aged children in the epicenter in West Texas and an adult in New Mexico have died of measles this year. All were unvaccinated.

Measles is caused by a highly contagious airborne virus and spreads easily when an infected person breathes, sneezes or coughs. It is preventable through vaccines, and has been considered eliminated from the U.S. since 2000.

- A new [national survey](#) of over 230 nursing leaders highlights growing concerns about how hospitals should support nurse managers. The [results show](#) that nurse managers are asking for more flexible schedules, help with administrative tasks, better technology, and stronger leadership training. While higher-level leaders agree these items are important, progress has reportedly been slow. Many nurse managers are stretched too thin and often [supervise very large](#)

teams, which increases the risk of burnout, the survey found. (The Nursing Beat, June, 2025)

- **AI Pen Detects Parkinson's Early (June 2025 from the Nursing Beat)** Biomedical engineers have developed an artificial intelligence (AI)-enhanced pen for handwriting analysis to aid early Parkinson's disease (PD) diagnosis. In a pilot study of three PD patients and 13 healthy participants, the pen achieved 96.22% accuracy in distinguishing PD from non-PD handwriting. The pen uses a magnetoelastic silicone tip and ferrofluid ink to convert handwriting into analyzable signals. This tool could complement existing diagnostic methods by supporting a crowd-sourced approach, especially in resource-limited areas. However, further large-scale studies are needed to validate its effectiveness. The study was funded through grants and awards to the investigators. **The Takeaway:** An AI-powered pen could help to identify PD early by analyzing patients' handwriting with high accuracy.

State

Texas Legislature 2025 The 89th Legislature's regular session ran from Jan. 14 to June 2, 2025. Although many bills related to nursing and health care were introduced only a few made it to the governor to sign into law, veto, or let pass without a signature. Some of those bills are listed below:

- **HB 2187 Howard, Donna(D) Relating to hospital staffing report processes and to retaliation and mandatory overtime protections for nurses. Companions: SB 2356 Perry, Charles(R) (Identical) Remarks: This bill would require a mandatory reporting process for data related to staffing committees, and would require DSHS to provide the data to HHSC for enforcement. The bill would also prohibit hospitals from retaliating against nurses who report violations of the staffing committee law. Finally, the bill would require HHSC to maintain a website to which nurses may report violations of staffing committee or mandatory overtime laws, and give HHSC the authority to investigate and impose administrative penalties for violations.**
- **SB 1829 Parker, Tan(R) Relating to human trafficking prevention, including training for first responders, disclosure of human trafficking information by certain health care facilities, and protection for facility employees who report human trafficking. Companions: HB 742 Thompson, Senfronia(D) (Identical) Remarks: This bill would prohibit facilities from retaliating against employees who report a suspected act of human trafficking in good faith. It would also require facilities to post signs with information on recognizing and reporting human trafficking.**
- **SB 2356 Perry, Charles(R) Relating to hospital staffing report processes and to retaliation and mandatory overtime protections for nurses. Companions: HB 2187 Howard, Donna(D) (Identical) Remarks: This bill would require a mandatory reporting process for data related to staffing committees, and would require DSHS to provide the data to HHSC for enforcement. The bill would also prohibit hospitals from retaliating against nurses who report violations of the staffing committee law. Finally, the bill would require HHSC to maintain a website to which nurses may report violations of staffing committee or mandatory overtime laws, and give HHSC the authority to investigate and impose administrative penalties for violations. Companions: HB 2190 Howard, Donna(D) (Identical) Remarks: This bill would provide immunity from criminal liability for health care providers for acts or omissions relating to the provision of health care services. The immunity would not apply if harm results from criminally negligent, reckless, knowing, or intentional acts.**
- **HB 1823 Thompson, Senfronia(D) Relating to the operation of a concrete crushing facility near a hospital. Companions: SB 2082 Miles, Borris(D) (Identical) Remarks: This bill would prohibit the operation of concrete crushing facilities within 440 yards of a hospital.**
- **SB 268 Perry and companion by Howard in HB 861. This bill clears up language and resources for relating certain complaints against health care practitioners.**

- SB 920 by Sparks and companion by Frank HB 3397 and was sponsored by Howard. This bill allows clarification of the law relating to administration of over the counter medications to certain public and private school students.

2025 Legislative Recap (excerpts for Texas Tribune)

Texas' Republican-controlled Legislature passed [several top GOP initiatives](#) during the regular 2025 legislative session. Lawmakers agreed to create a [school voucher program](#), [ban DEI initiatives in public schools](#), increase [political appointees' control of state universities](#), [prohibit consumable THC products](#) and let voters decide whether to improve the [state's water infrastructure](#). This is a look at what officials passed — or didn't — on a number of fronts. Lawmakers sought to close gaps in education and support funding for agriculture, disaster preparedness and health care this year.

- Rural health
 1. Texas lawmakers took several steps to address problems with rural health. This includes a bill that provides more support for rural hospitals. Experts say it could have helped prevent the closure of a hospital in East Texas during the legislative session.
 2. The [Mid Coast Medical Center](#) closed down its operations in Trinity, a town of about 2,400 that is 90 miles north of Houston, citing financial concerns. Rural hospital closures slowed in Texas after the state saw an influx of federal funding for rural health care as part of the national response to COVID-19. The funding has ended, but inflation hasn't, leaving many rural hospitals with tough financial choices. [House Bill 18](#), by [Rep. Gary VanDeaver](#), R-New Boston, is known as the Rural Health Stabilization and Innovation Act. It seeks to give more support for rural hospitals by creating a State Office of Rural Hospital Finance to provide hospitals with technical assistance. [Lynn Cowles](#), the health and food justice director for [Every Texan](#), a public policy institute in Texas, said the bill is good but requires a lot of oversight and monitoring. "We do want to make sure that the bill's emphasis on administrative improvements and training is going to serve the bill's intent and not line pockets for consulting firms," Cowles said.
 3. The bill also creates a Rural Hospital Financial Vulnerability Index and Needs Assessment, which will evaluate the financial health of rural hospitals, along with a Rural Pediatric Mental Health Care Access Program and other measures. Under the bill, each hospital's reimbursement rates will be updated every two years.

4. Rural emergency services will also get a boost from lawmakers. [House Bill 3000](#) by state Rep. [Ken King](#), R-Canadian, addresses the lack of resources for rural emergency services, which largely happens because of tight budgets that keep medical departments from affording equipment. The bill establishes a grant program for qualified rural counties to purchase ambulances as a way to strengthen emergency services and improve response times.
- Disaster recovery and emergency preparedness
 1. Lawmakers also passed a bill directing the state's emergency division to establish a disaster recovery program. Authored by Rep. [Trent Ashby](#), R-Lufkin, [House Bill 3010](#) makes new money available to certain counties, cities and colleges when extreme weather devastates infrastructure. The bill does not include specific amount. Counties must have fewer than 100,000 residents to apply for this funding, which will be administered by the Texas Division of Emergency Management. To be eligible, the cost of restoring destroyed infrastructure must exceed 10% of what the county collects in state and local sales taxes. Applications must include an estimate of the total cost of the repairs and evidence that the project does not qualify for federal assistance. "We're on our own for the first 72 hours [of a disaster]," Ryder said. "Everything is spent, and then we hope we get reimbursed by FEMA."
 2. [Another bill](#) by Rep. [David Spiller](#), R-Jacksboro, seeks to eliminate the disparities between rural and urban firefighting and rescue capabilities. The bill requires Texas A&M Engineering Service to conduct a study that evaluates the disparities and provide recommendations on how to improve it. Another requirement is that the study considers several factors, including available funding for personnel and equipment and the number of qualified candidates to fill new or vacant positions. The study is to be submitted by Dec. 1, 2026 to the governor, lieutenant governor and speaker of the House.
 3. Lawmakers also passed a slew of bills aimed at [preparing the state for wildfires](#) and mitigating the damage. The package of legislation includes 10% of money in the Rural Volunteer Fire Department Assistance program to go to volunteer firefighters at risk for wildfires.

National

- Save Healthcare Workers Act would make it a federal crime to assault or otherwise interfere with health care workers while they are working. This bill has not been introduced to the House or Senate yet (as of 5/6/25). ENA is working with Rep. Madeleine Deen (D-PA) and Sen. Cindy Hyde-Smith (R-MS)

to get bill introduced to both chambers. This is a refiling of H.R. 2584/ S. 2768 from the 118 Congress (2023-2024). It was previously named the Safety from Violence for Healthcare Employees (SAVE) Act.

- H.R. 929/ S. 266 Dr. Lorna Breen Health Care Provider Protection Reauthorization Act: provides direct support and training to combat mental health struggles among health care workers. This program has already provided more than \$100 million to support these workers, and ENA is looking to extend that program by an additional 5 years. Referred to House Energy & Commerce Committee, Senate Health, Education, Labor, and Pensions (HELP) Committee for hearings.

Texas Board of Nursing - Continuing Education Requirements for RNs

All Texas RNs are reminded to review the Texas Board of Nursing's mandatory continuing education re-licensure requirements located on the website at https://www.bon.texas.gov/education_continuing_education.asp#D

There are several factors which must be kept in mind when reviewing the information on the website:

- Course content must meet the stipulation requirements of the Texas Board of Nursing
- The time frame or licensure cycle for repeating the requirement differs from course to course
- The RN's practice type and/or 'float unit' may determine if a nurse needs to take a course
- Advance Practice RNs (APRN) have additional course requirements than RNs
- Course requirements are not automatically met with certification
- Additional education requirements may be added at any time. These requirements are announced in the Texas Board of Nursing's Bulletin.

Current RN Requirements:

- Forensics Evidence Collection
- Older Adult and Geriatric Care
- Nursing Jurisprudence and Ethics
- *Human Trafficking Prevention

****Must be an approved Texas HHS course.***

Current APRN Requirements:

- Pharmacotherapeutics
- Tick-Borne Diseases
- *Pain management and prescription of opioids
- *Prescription of opioids
- Authorization to receive information from the Texas Prescription Monitoring Program

**** All APRNs with prescriptive authority authorized to prescribe opioids***
